

Walther Free Optic Rebate - Terms and Conditions

Thank you for purchasing a Walther PDP or PDP F-Series. Follow these terms and conditions to claim your rebate for a Free C+H Duty Optic (red dot).

Eligibility

- **Who Can Participate:**
 - This offer is valid only in the 50 United States, Washington, D.C. and Puerto Rico.
 - The offer is void where prohibited, restricted, or taxed by law, including the U.S. Virgin Islands.
 - Customers are responsible for ensuring compliance with local laws before submitting a rebate claim.
 - Dealers, distributors, and retailers are **not** eligible.
- **Eligible Purchases:**
 - Purchase a **new** Walther PDP or PDP F-Series between **November 1, 2025 and December 31, 2025**.
 - **Excluding all Pro ACRO, LE models and any PDP with pre-installed optic.**
 - Only new firearms (not previously purchased, owned, or used) qualify.
 - **Each rebate claim must be submitted for a single firearm purchase.** If you buy multiple qualifying firearms, submit a separate claim for each, ensuring you include a copy of the UPC/Serial Number label and receipt for each firearm.

How to Submit Your Rebate Claim

- **Deadline:**
 - Submit your rebate claim by **11:59 PM CST on January 31, 2026**.
- **Submission Method:**
 - All claims must be submitted online at <https://waltherpromos.com>.
 - **Mailed-in claims will not be accepted.**
- **Required Information:**
 1. **Serial Number:** Enter the verified serial number of your firearm. Double-check for accuracy before submitting.
 2. **UPC Code:** Enter the 12-digit UPC code from your firearm label.
- **Required Uploads:**
 1. A clear photo or scan of the original UPC and serial number label from the end of the firearm box.

- After submitting a properly completed claim with all required documentation:
 - Your claim will be verified by Walther.
 - Allow **8-10 weeks** for the item to arrive.
 - **Important Notes:**
 - Walther is not responsible for lost, late, or misdirected submissions.
 - Errors or delays due to technical issues (e.g., computer malfunctions) are not the responsibility of Walther.
